Video Testimony - Child abuse victims are interviewed on videotape in a casual environment to reduce the stress associated with multiple interviews. During the 12 month grant period ended September 30, 2021, we served a total of 52 victims. Of the victims served, 24 received therapy services, and 37 received criminal justice support via video forensic interviews/testimony.

On-site counseling - Child victims and their non-offending family members are provided counseling services at the West Alabama Children's Advocacy Center, and referred to off-site counselors as requested. Our counseling service provided 190 sessions to victims of abuse, and non-offending family members.

Community Programs - Age appropriate child safety education is normally provided each year to approximately 300-500 elementary age school children in our area using our puppet show and other presentations. However, due to years 2020-2021 COVID restrictions, this program was temporarily suspended. We plan to resume this program for the upcoming school year.
